In the field of information technologies, he works on operations such as collection, storage, protection, processing, transmission of various information through EHM and computer networks.

The improvement of the procedure for the provision of electronic state services includes the mandatory unification of documents of state bodies.

The introduction of electronic state services is carried out through the mandatory implementation of measures to improve the procedure for their provision.

The information systems created as a result of the implementation of measures to improve the procedure for the provision of electronic state services include a number of obligations, such as integration with the Unified Interactive State Services Portal of the Republic of Uzbekistan the implementation of measures to improve the procedure for the provision of electronic state services is ensured on a permanent basis by state bodies and other organizations providing electronic state services, as well as by the Ministry of Information Technologies and Communications Development of the Republic of Uzbekistan in accordance with the Regulation approved by this decision. A single interactive portal of state services (my.gov.uz) has been launched to provide electronic state services to citizens and business entities in today's time, providing quick services, offers and questions.

The Unified Interactive State Services Portal of the Republic of Uzbekistan (hereinafter referred to as the Unified Portal) operates on the Internet within the framework of the Government Portal of the Republic of Uzbekistan, including on the "one-stop" principle. Provision of interactive state services through a single portal of the Cabinet of Ministers of the Republic of Uzbekistan of September 15, 2017 "On measures to improve the procedure for providing electronic state services through a single interactive state services portal of the Republic of Uzbekistan" No. 728 It is carried out for users who have passed the registration and authorization processes in accordance with the Regulation on the Unified Interactive State Services Portal of the Republic of Uzbekistan, provided in Decision No. The single portal is the single point of free use of interactive public services provided by state bodies, including those provided on a paid basis. The main tasks of the single portal;

·give users the opportunity to apply directly to government bodies;

integration of users with other projects in the field of information and communication technologies;

improving the effectiveness of users' interaction with state bodies;

reducing and eliminating bureaucratic obstacles for users when applying to state bodies; Further development of the "Electronic Government" system and assistance in the introduction of modern information technologies to public administration. The single portal is designed to develop conditions and expand the possibilities of users in receiving interactive state services based on the use of modern information technologies. Today, 218 electronic state services are provided through this portal, including 156 types of new services introduced in 2022. In particular, online payment for housing and communal services, electronic appointment of a doctor, permanent and temporary registration of citizens, registration of cadastral passport and services of obtaining state subsidies for mortgage loans and a number of other services were transferred to electronic form and launched through the portal. The youth group refers to citizens of different ages in different countries of the world. For example, in the USA and Japan, people between the ages of 13-14 and 29-30 are considered youth, in Bulgaria, between 15 and 29, and in Russia, between 15 and 30. In Germany, "young people" are divided into 14-18 years and "older people" 18-27 years. In the Republic of Uzbekistan, persons who have reached the age of 14 and are under the age of 30 constitute the category of youth, according to Article 3 of the Law of the Republic of Uzbekistan "On State Policy Regarding Youth". It should be noted here that this law, adopted on September 14, 2016, defined the main directions of the state policy on youth (Article 5). Among these directions, educating young people in the spirit of respect for laws; There are also ways to raise the level of their legal consciousness and culture. In order to ensure the rights of young people, not only the guarantee of state bodies, but also the level of legal consciousness and culture of young people is of great importance.

The effectiveness of the reforms in this regard largely depends on their thoroughness and systematicity. Taking this into account, we would like to make several proposals on the issue of raising legal awareness and culture among young people.

First of all, you should pay attention to this!

- *It is necessary to increase legal materials in the media space by effectively using today's information technologies!*
- *Registration of every citizen and youth in a single identification system from electronic government portals! This will give us a great impetus for digital development today.*
- *To give them various tasks through the unified electronic portals of the state, to ensure that they can work and use this system to the maximum extent, to strengthen control and carry out propaganda work!*
- *Make every growing young person feel and strengthen their rights and obligations!*
- *One of the most urgent issues among today's youth is "Increasing free thought and (free) speech"!*
- *It is necessary to make simple, compact, interesting and short postings (laws, decisions, decrees, orders) issued in our country today in the media space regularly and quickly!*
- *In addition, I believe that the time has come to create regional programs for the development of legal education of young people!*
- *I think that the presence of unique programs in higher educational institutions and at the level of regions and districts will lead to an increase in legal awareness and culture among young people! For example, the district governor's award named "Young Lawyer", the regional governor's trophy named "Defender of the Law" and "Legal Promoter", rector's cup, dean's cup, and similar new events can lead to an increase in interest in legal knowledge among young people.*
- *We believe that it will be effective to start legal education from a pre-school educational institution. After all, it is necessary to inculcate concepts such as the constitution, law,*

citizenship, rights, and obligations to children from this age. This consistency of legal education is important because it has a constant audience and ensures the gradual achievement of legal literacy.

In conclusion, it can be said that high legal awareness and civility among young people is important in building a democratic legal state and civil society. In short, only a well-thought-out and prompt state policy can raise the legal culture of young people and help raise the level of their legal consciousness.
